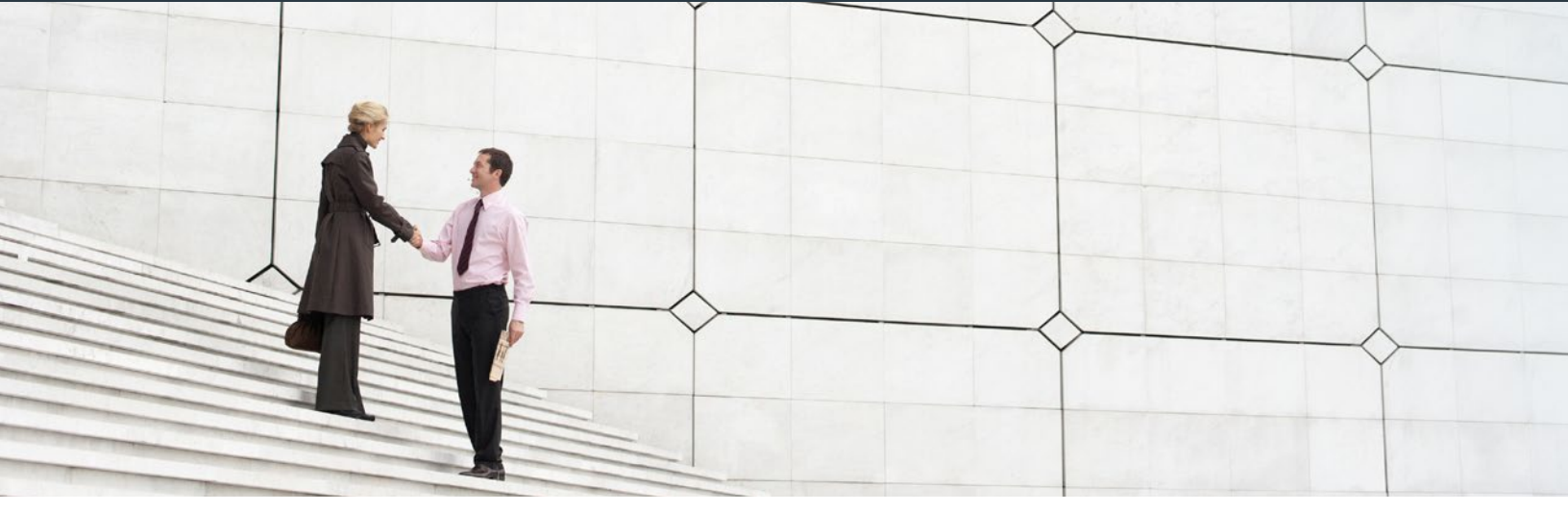

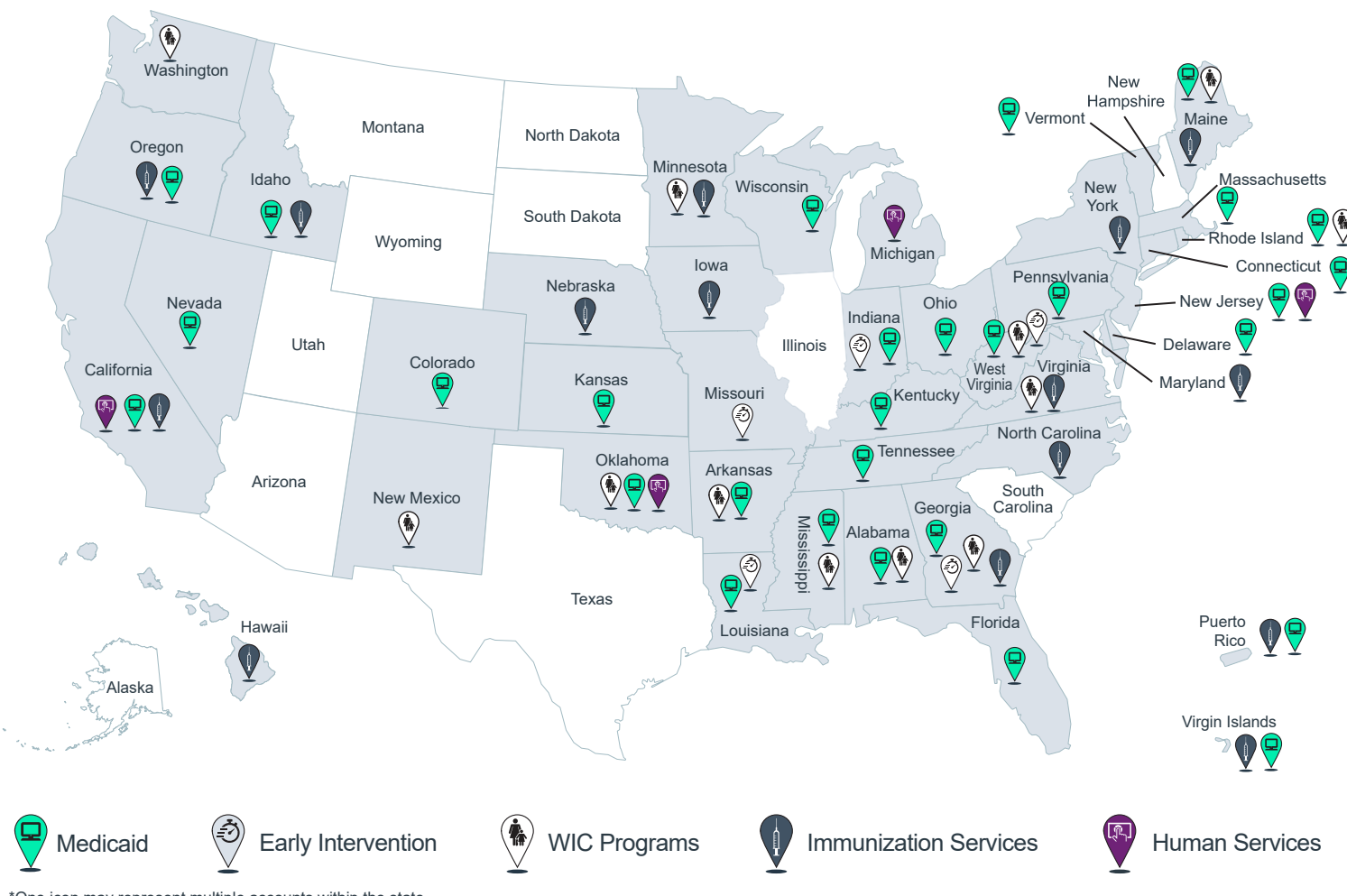

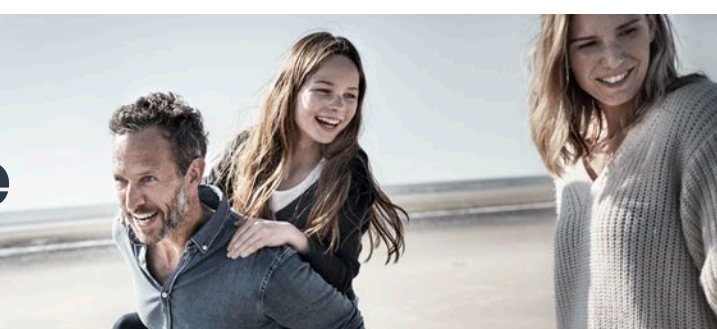

Making a Difference



- We support one of the largest U.S. eligibility systems with a single automated system to **improve customer service and case management** for several public assistance programs in 18 jurisdictions. This helps ensure that 5.5M+ active clients receive benefits consistently, accurately and in a timely manner.
- We implemented a user-friendly Electronic Visit Verification solution to help a Midwestern state comply with the 21st Century Cures Act. The system handles 30K+ EVV contacts monthly, using data and technology to **improve oversight** of Medicaid member care outside of the clinical setting and **reduce payment of fraudulent claims**.
- The Medical Assistance Provider Incentive Repository (MAPIR) embodies CMS' vision for collaboration, cost sharing and coordination in administering the federal EHR incentive program. It reflects 14 states' decision to unite to achieve that. **The program has issued \$1.5B+ in incentive payments** to providers across the country.
